The following is a Company Announcement issued by Premier Capital p.l.c.(the "Company") in terms of the Capital Market Rules.

QUOTE

The Company announces that the Audited Consolidated Financial Statements for the financial year ended 31 December 2021 have been approved by the Board of Directors. A copy of the signed Audited Financial Statements are attached herewith and are also available for viewing on the Company's website https://www.premiercapital.com.mt/financial-statements/

It is being announced that a consolidated profit before tax of $\leq 32,227,000$ was projected in the Financial Analysis Summary published in June 2021 and that the Company closed the Financial Year Ending 31 December 2021 with a consolidated profit before tax of $\leq 38,509,633$. The Company had also projected a consolidated profit after tax amounting to $\leq 28,790,000$ and the company closed the Financial Year ended 31 December 2021 with a consolidated profit after tax of $\leq 34,303,476$.

The variance arises mainly from actual performance exceeding projected results which at the time were still extrapolated in a pandemic-shrouded uncertainty. The Group registered an increase in turnover of over ≤ 12.5 million (3.2%) which contributed to an increase in EBITDA of over ≤ 4.7 million (7.3%). All markets contributed to different extents to the betterment in results.
